

Arizona Attorneys for Criminal Justice Membership Application

AACJ BY-LAWS: ARTICLE V: Membership; Section 1. Persons Eligible

Except as set forth in Section 2 of this Article, the following persons are eligible for membership in the organization:

- Any attorney who is a member of any state bar is eligible for membership.
- Any law student, paralegal or law clerk is eligible for non-voting membership.
- Any professional person who is involved with the criminal justice system but is not an attorney, and is in agreement with the purposes of the organization is eligible for non-voting membership as an Allied Professional of Arizona Attorneys for Criminal Justice.

Section 2. Persons Not Eligible for Membership

Persons employed in the offices of prosecutors, including, but not limited to, U.S. Attorneys, City Attorneys, County Attorneys or Attorneys General are not eligible for membership in. Any person engaged in a full-time judicial function, including any full-time judge, commissioner or referee, is disqualified from membership. Any question regarding membership shall be referred to the Executive Committee, who by a 2/3 vote for approval shall refer the question to the Board of Governors. If the Board of Governors approves the application by a 3/4 vote, the application shall be accepted.

A person who meets the following criteria may be approved by the Board for full membership:

- Member in good standing of any State Bar;
- Devotes a substantial portion of his or her practice to criminal defense law;
- Spends no more than twenty-five percent (25%) of the time devoted to his or her law practice as a prosecutor.

If you are an allied professional, an AACJ member must recommend you for membership.
